Breeding season is under way here in Arkansas. Remember that you need to provide proper nutrition to the ram and ewe to be able to get them to settle. With the temperature falling this time of year, be sure to maintain quality water to the animals along with proper nutrition. Lambing will be starting soon so it's time to start thinking about where you will be lambing. Also, start thinking about a lambing kit to have available when that newborn start showing up. I suggest an old towel, gloves and Iodine for the navel. If your area requires you to use a heat light to provide extra heat for the newborn lamb be sure you put in a safe place that will not burn the lamb or your barn. There is not anything more tragic than barn fires.

We had a good National meeting during NAILE this past November. I would like to welcome Amber Claflin as the newsletter editor. I feel that she will be a great addition to the team. We have a great association, but I would urge members to get involved in the association. We have a good group of young people that are wanting to be involved in the association, so I feel that we, as parents or grandparents, need to support the young people as they are the future of the sheep industry. CBA Meeting Minutes November 10, 2018

The Cotswold Breeders Association held its Annual Meeting in conjunction with its National Show at N.A.I.L.E. on November 10, 2018. The meeting was called to order by President, Butch Watson at 6:10 p.m. following a pot luck meal. Attending the meeting were Butch, Lensey, and Dianna Watson; Sam Kruppenbacker; Ben Kruppenbacker; Lauren, Jill, and Brian Mohr; Emilio and Martha Smith Gomez; Ronald Smith; Clara Gomez Smith; Cassandra Pichards; Tim, Mende, Ava, and Addison Kemper; and Tony and Ann Kaminski (on phone).

Minutes of the 2017 meeting were never provided; therefore, no minutes were read.

The Treasurer's report was presented by Ann Kaminski. Income for the past year amounted to \$3,235.25. Expenses were \$1,717.76. The Savings Account balance is \$5,713.70. The Checking Account balance is \$5,128.39 giving a total balance of \$10,842.09. Ann reported that she had never received a billing from the 2017 N.A.I.L.E. Show or for our 2017 website. A motion was made by Brian Mohr and seconded by Dianna Watson to accept the treasurer's report. Motion carried. Treasurer's report is attached.

Entry fees due Cotswold Breeders Association were discussed as to whether they were covering the cost of N.A.I.L.E. or if some other means needed to be explored. Since the 2017 charges had not been received it was hard to determine if the additional fees will cover the needed amount without further funding.

Butch Watson emphasized the importance of getting the Director's reports turned in to Dianna Watson in a timely matter for the newsletter.

The website update was discussed once again. Dianna Watson volunteered to get in contact with Doug Meyer and update the website. Ann Kaminski is getting Butch Watson contact information for Doug Meyer. The group was also reminded about the Cotswold Facebook page.

Dianna Watson moved that at the 2019 N.A.I.L.E. Show having a trial run of a Silent Auction that would begin on the Junior week-end and run through the end of the Open Cotswold Show to help supplement the show expenses. Ava Kemper seconded. Motion carried.

It was also discussed about the possibility to see if we could get some of the old California sponsors to help support our show.

A discussion on registration and transfer fees for members vs non-members ended in Brian Mohr moving that "as of January 1, 2019 registration and transfer fees for non-members will be \$20.00. Butch Watson will also check with Jeff Ebert concerning the charging and handling of rush fees.

CBA Meeting Minutes November 16, 2019

The Cotswold Breeders Association held its Annual Meeting in conjunction with its National Shows at N.A.I.L.E. on November 16, 2019. The meeting was called to order by President, Butch Watson, at 5:54 p.m. following a pot luck dinner.

Jeff Ebert from Associated Registers stopped by during the pot luck to entertain any questions from our breeders. Butch Watson asked if it would be possible and the cost to split the natural color and white breeders so that a list could be published to our website making it easier for our members and visitors to find the animals that they are looking to purchase. Jeff is going to look into this when he returns to the office and advise Butch on the possibility and cost.

Attending the meeting were Butch, Lensey, Landen, and Dianna Watson; Jonathan Short; Christina Hill; Laurie and Sam Kruppenbacher; Ronald Smith; Martha and Emilio Smith Gomez; Cari and Nann Green; Mary Anne, Ava, Tim, and Addison Kemper. Those in attendance via conference call Ann and Tony Kaminski; Amber, Doug, and William Claflin.

Butch Watson reminded the group that they must be 2019 paid members to make a motion or to vote; however, he welcomed comments from anyone present.

The minutes from the 2018 meeting was presented by Lensey Watson. A motion was made by Dianna Watson and seconded by Ava Kemper to accept the minutes as read. Motion carried.

The Treasurer's Report was presented by Ann Kaminski. Everyone present was provided a copy of the report. There was a clarification on the double expense for the National Show. The 2017 NAILE Show was not paid for in 2018; therefore, both shows were paid in 2019. A motion was made by Mary Anne Kemper and seconded by Dianna Watson to accept the treasurer's report. Motion carried.

Butch Watson explained that starting this year NAILE is going to a new pay scale on money that comes to the exhibitors from NAILE. The Association will only pay NAILE the difference between the premium amount and what NAILE pays.

Dianna Watson reported that Doug Meyer had updated the website. He also has added a Junior tab with futurity, ambassador, and scholarship forms are already posted. We can post junior activities and ambassador information of interest to all junior members on this tab.

The trial run of the Silent Auction is looking successful. At 4:00 p.m. on November 16th we already had \$156.00 bid. The auction will run until the end of the National Show on November 19th. There was a discussion concerning where the organization wanted to ear mark the Silent Auction proceeds to fund. Ann Kaminski and Amber Claflin both suggested it go towards NAILE expenses. A comment was made about junior awards for showmanship, lead line, and junior show. A motion was made by Ann Kanimski and seconded by Dianna Watson that the money raised from the Silent Auction will be used for junior show incentives at NAILE. Motion carried.

Butch Watson reported that the Associated Registry as of October 24, 2019 had registered 188 animals with three being over twelve months of age and one to a non-member; transferred seventy-nine sheep and received dues for thirty-four senior members and nineteen junior members.

The question about the Associated Registry rush fee policy was brought up. Butch Watson explained to the group that Jeff Ebert only charges the Association \$3.15 for registering the animal. This is the fee that is charged regardless if it is a rush or not. Ann Kaminski said that on the June and July statement that there were request fees that the Associated Registry did not collect and the Association had to pay. Butch Watson is going to check with Jeff Ebert on this matter.

The discussion about hosting Regional Shows was brought up once again. Dianna Watson reported that the Arkansas-Oklahoma State Fair was willing to work with the Association to have a Southeast Regional Show. It was decided to see what interest there was in Arkansas/Missouri/Illinois in have a regional show in that area.

It was reported that the Big E Regional Show had thirty-seven sheep shown; however, funding is really not there to support a regional open show. Their money is ear marked for the junior shows.

It was the consensus of the membership for people to gather information in their region concerning hosting a regional show and report back to their director or Butch Watson.

Jonathan Short volunteered to make a map where the Cotswold sheep are located to help decide the regions that would likely have successful regional shows. Dianna Watson is to get membership list to Jonathan.

It was reported that entry numbers for NAILE were up this year. It was the largest Junior Show that we have had at NAILE and the largest Open Show that we have had in several years.

Website contact updated finally. It was explained that we have to go through Doug Meyer to make changes. We as an Association cannot just go to the website and put something out or change something that is there. Butch Watson explained that we pay Doug Meyer \$224.00 per year to maintain our website plus \$30.00 per hour to make changes and updates. Amber Claflin commented about Doug Claflin looking into host cost. Nann Green is going to talk with Montadale Association to see what their yearly and update charges are so we would have something to compare to.

Butch Watson reminded the group that officer elections were coming up. If you are planning to run for office, you need to get your bio to Ann Kaminski by November 30th. Officers that will be elected for a two year term this year are President, Vice-President, and Secretary. Treasurer is a four-year term and Ann Kaminski has two years remaining. Ann Kaminski reminded the group that you must be a paid member of the Association for two years in order to run for office. Butch Watson reminded everyone to read the by-laws for the qualifications and responsibilities associated with each office.

Dianna Watson asked to be replaced as the Newsletter Editor due to new obligations at the University of Arkansas. Amber Claflin has volunteered to take this position. Ann Kaminski moved that the meeting be adjourned. Tony Kaminski seconded. Meeting was adjourned at 7:10 p.m.
